Engel, a Harvard Law School graduate, served as an assistant prosecutor in Ohio and Massachusetts. He led the Warren County Prosecuting Attorney's Office's appellate division, where he not only handled appeals for the office, but was also called upon by state and national law enforcement organizations to write *amicus curiae* briefs to the Ohio Supreme Court and the United States Supreme Court. Engel also served as Chief Legal Counsel for the Ohio Department of Public Safety and as an associate at Choate, Hall & Stewart, a large Boston law firm. Engel's experience includes death penalty trials, arguments before the Ohio Supreme Court, and the representation of Fortune 500 companies, including Microsoft, Hewlett-Packard, and Travelers.

Martin, a University of Cincinnati Law School graduate, served as an assistant prosecutor in Ohio. She has been called a "Drunk driving attorney extraordinaire" by 700WLW. Martin served as a statewide "resource prosecutor" who trained judges, prosecutors, police, and attorneys on OVI/DUI issue. From 2011 through 2014 Martin was the Director of Ohio's Alcohol and Drug Testing Program under the Ohio Department of Health. As Director, she managed, planned, directed, evaluated, and administered all activities of Ohio's Breath Testing Program and oversaw Ohio's laboratory blood and urine testing techniques and certification.
